Clinical Experience:

In Egypt, after completing my house officer job, I began postgraduate training in Anaesthesia at El-Minya University Hospital, El-Minya, Egypt. During the training period, I achieved competence in the anaesthetic management of all the routine cases including day-case surgery, general surgery, gynecology and obstetrics, orthopedic, urologic, ENT, and eye surgeries, and laparoscopic procedures in general surgery and gynecology. I was trained to give general and regional anaesthesia including intrathecal, epidural, and caudal techniques. I also had on-calls for anaesthetic management of emergency cases. My work was fully supervised either in the theatre or in the hospital. As an assistant lecturer, I was involved in management of more complicated cases either elective or emergency.

In the UK, I did clinical attachment in Anaesthetic Department, Diana Princess of Wales Hospital, Grimsby. During this period, I have attended the preoperative assessment and anaesthesia of the surgical cases in a variety of surgical branches (including ENT, Ophthalmology, General surgery, vascular surgery, Orthopaedics, Gynecology & Obstetrics, dental, MRI and Urological cases).

Then, I had a locum SHO anaesthesia, Hull Royal Infirmary. I participated in the preoperative assessment, anaesthetic administration, and postoperative management of both adult and paediatric cases in these lists (general and vascular surgery, orthopaedics, urology, ENT, ophthalmology, and gynecology) with appropriate supervision in the theatre or in the hospital. Afterwards, I had a rotational post as SHO Anaesthesia at University Hospitals of Leicester NHS Trust. This post was organized by Leicester. I have done general duties, including general, orthopaedic, urologic, vascular, and ENT surgeries, at the Leicester General Hospital and Glenfield General Hospital; obstetrics at the Leicester Royal Infirmary; and general duties and ITU at the LRI. I have been out of Leicester to Grantham and Boston Hospitals. I had on-calls (covering emergency

cases, cardiac arrest, and acute pain management). In addition, I did the pain round as a member of the acute pain service team on my on-call days.

Then, on coming back to Egypt, I continued my job as assistant lecturer in anaesthetics till I have finished my Ph. D. thesis and I had Been promoted to the lecturer post. During this period, I gained clinical experience in anaesthesia for cardiothoracic, vascular, and neurosurgical cases.

Research, Audit and Teaching:

- I was involved in a study about the laryngeal mask airway entitled "Comparison of the Laryngeal Mask Airway and Tracheal Intubation During Spontaneous Respiration". This thesis was submitted to El-Minya university, Egypt for partial fulfillment of the master degree and accepted in 1996.
- I was also involved in a study entitled "Comparative Study of the Effects of Sevoflurane and Isoflurane Anaesthesia on Renal and Hepatic Functions" in El-Minya university hospital, Egypt, and it was submitted for partial fulfillment of the Ph.D. Degree. It was accepted in 2007.
